1. Cancellation Policy: I understand and comply with the cancellation policy for NAARVA rallies and special events.
2. Affirm that I (we) have not been diagnosed with, demonstrated any symptoms of or have in any way been exposed to any communicable diseases (including but not limited to the virus commonly referred to as COVID-19) within the past thirty days.
3. Acknowledge that I (we) am/are aware that by entering the premises and participating in the EVENT(S) that there are risks to me and to those with whom I (we) interact of exposure, directly or indirectly, to communicable disease(s) including but not limited to the virus "severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)", "COVID-19" and/or any mutation or variation thereof.

The undersigned attendee agrees to comply with mask, social distancing and other COVID-19 protocols required by applicable government bodies, the Sponsor, and/or venue mandates. **Failure to do so may result in the attendee being asked to leave an event and may result in the forfeiture of any registration fee.**
